

### ISLANDS AT DORAL (NE) COMMUNITY DEVELOPMENT DISTRICT REGULAR BOARD MEETING MARCH 11, 2025

### A. CALL TO ORDER

The March 11, 2025, Regular Board Meeting of the Islands at Doral (NE) Community Development District (the "District") was called to order at 7:01 p.m. in the Second Floor Conference Room of Doral Legacy Park located at 11400 NW 82<sup>nd</sup> Street, Doral, Florida 33178.

### **B. PROOF OF PUBLICATION**

Proof of publication was presented that notice of the Regular Board Meeting had been published in the *Miami Herald* on November 1, 2024, as part of the District's Fiscal Year 2024/2025 Meeting Schedule, as legally required.

### C. ESTABLISH A QUORUM

It was determined that the attendance of Chairman Jesus Arias and Supervisors Dunia Cuneo and Denis Schiavi constituted a quorum and it was in order to proceed with the meeting.

Staff in attendance included: District Manager Gloria Perez of Special District Services, Inc.; and General Counsel Gregory George of Billing, Cochran, Lyles, Mauro & Ramsey, P.A.

### D. ADDITIONS OR DELETIONS TO THE AGENDA

There were no additions or deletions to the agenda.

### E. COMMENTS FROM THE PUBLIC FOR ITEMS NOT ON THE AGENDA

There were no comments from the public for items not on the agenda.

### F. APPROVAL OF MINUTES 1. January 14, 2025, Regular Board Meeting

The January 14, 2025, Regular Board Meeting minutes were presented for approval.

A **MOTION** was made by Supervisor Schiavi, seconded by Supervisor Arias and unanimously passed approving the minutes of the January 14, 2025, Regular Board Meeting, as presented.

### G. OLD BUSINESS

There were no Old Business items to come before the Board.

### H. NEW BUSINESS

# 1. Accept and Receive Master Association Request for Amendment to Existing Maintenance Agreement

Presented in the meeting materials was the Notice of Termination of Certain Responsibilities from the Master Association requesting an amendment to the existing maintenance agreement between the Master Association and the District.

A **MOTION** was made by Supervisor Cuneo, seconded by Supervisor Schiavi and unanimously passed accepting and receiving the amendment to the existing Maintenance Agreement between the District and the Master Association, as presented.

# 2. Consider Amendment between the District and Master Association Maintenance Agreement

A **MOTION** was made by Supervisor Cuneo, seconded by Supervisor Arias and unanimously passed approving the amendment to the Master Association Master Maintenance Agreement between the District and the Master Association, effective October 1, 2025, and further authorizing District Counsel to prepare the amendment.

Supervisor Nestor Garcia arrived at approximately 7:14 p.m.

# 3. Discussion Regarding Proposed 2025 O&M Assessment for District Roads and Drainage System

Presented in the meeting materials was the Proposed 2025 O&M Assessment for the District's roads and drainage system prepared by the District Engineer.

### 4. Consider First Amendment to SDS Agreement

Field Operations are the services rendered to the District. Field Operations management services that SDS, Inc. provides in the District includes but is not limited to the coordination and communication with contractors for required maintenance and improvements, solicitation of bids/cost quotes, management of contracts, site visits and inspections. The proposed fee is in the amount of \$3,000 per year, payable in in monthly installments of \$250.

A **MOTION** was made by Supervisor Garcia, seconded by Supervisor Arias and passed unanimously approving the First Amendment to the SDS Agreement, adding Field Operations management services, amended to reflect the reduction of the number of site visits to six (6) times per year at the annual rate of \$1,500.

### 5. Consider Resolution No. 2025-04 – Adopting a Fiscal Year 2025/2026 Proposed Budget

Mrs. Perez presented Resolution No. 2025-04, entitled:

### **RESOLUTION NO. 2025-04**

### A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE ISLANDS AT DORAL (NE) COMMUNITY DEVELOPMENT DISTRICT APPROVING A PROPOSED BUDGET FOR FISCAL YEAR 2025/2026; AND PROVIDING AN EFFECTIVE DATE.

Mrs. Perez advised that the Debt Service Assessment is the same as last year. The way the refunding was set-up there will be a large balloon payment in the amount of \$2,225,000 due at maturity in 2029. A new loan will be needed at that time. By collecting the pre-refunding rates, bond prepayments can be made, thereby greatly reducing the loan that will be needed in 2029. A prepayment of \$225,000 was made in November 2024, therefore the 2029 payment is estimated at \$1,030,000.

The proposed Administrative Assessment is similar to last year with a slight increase of \$2.36. The Maintenance Assessment has increased by \$186.34 as a result of the District having to assume the maintenance responsibilities effective in FY 2025/2026 for the District owned roadways, stormwater management system and related expenses. Said maintenance items are currently funded and maintained by the Master Association pursuant to a Maintenance Service Agreement that was Amended at the request of the Association, thereby providing an assessment increase of \$188.70, which equates to approximately \$15.73 per month.

Estimated available funds projected for 9-30-2025 are approximately \$60,000, should no unforeseen expenses occur. No carryover balance has been applied to the presented budget.

Because the overall assessment for 2025/2026 is currently higher than the FY 2024/2025 assessment, letters to the residents/owners will be required.

A discussion ensued after which:

A **MOTION** was made by Supervisor Schiavi, seconded by Supervisor Cuneo and unanimously passed adopting Resolution No. 2025-04, approving a Proposed Budget for FY 2025/2026, amended to reflect reducing the Field Operation Services and budgeted amount to \$1,500, and setting the Public Hearing for finalization for <u>May 13, 2025, at 7:00 p.m.</u> at the Doral Legacy Park, 2nd Floor, Conference Room located at 11400 NW 82nd Street, Doral, Florida 33178; and further authorizing the advertisement as required and notices to the homeowners.

### I. ADMINISTRATIVE MATTERS 1. Financial Update

Mrs. Perez presented the financial statement through January 2025. She pointed out that the available funds as of January 31, 2025, were \$127,120.69.

A **MOTION** was made by Supervisor Garcia, seconded by Supervisor Cuneo and passed unanimously ratifying and approving the financial statement, as presented.

## J. DISTRICT COUNSEL REPORT 1. Stormwater System Legal Requirements Update Memorandum

Mr. George provided the Board with an overview of the stormwater system's legal requirements.

## K. BOARD MEMBER/STAFF COMMENTS

There were no further comments from the Board or staff.

## L. ADJOURNMENT


